The RADPAC Report

RADPAC fundraising is on pace with last year's fundraising at this time however we still have room for improvement. From 1/1/2021-8/29/2021 RADPAC raised \$589,258 compared to 1/1/2022-8/29/2022 where RADPAC has raised \$567,238.

In 2022, RADPAC has disbursed \$449,630 to Members of Congress and candidates running for Congress. Out of this \$449,630, 52% went to Democratic campaigns and 48% went to Republican campaigns.

RADPAC has also participated in more than 60 events for Members of Congress in DC this year.

Just a few weeks ago, CMS released its proposed rule that estimates an overall impact of the Medicare Physician Fee Schedule (MPFS) proposed changes to radiology to be a 3%

decrease, a 4% decrease for interventional radiology, a 3% decrease for nuclear medicine, and a 1% decrease for radiation oncology and radiation therapy centers if the provisions within the proposed rule are finalized. However, the cuts could be much larger without congressional action.

Unfortunately, we have been down this road before. But, with sufficient resources, the ACR's Government Relations team and RADPAC can fight to mitigate these proposed cuts.

As a member of the radiology community, it is YOUR civic duty to ensure the continued success of the specialty and patient's access to services by contributing to RADPAC, the nonpartisan pro-radiology voice in DC. While RADPAC remains one of the top five political action committees among physician groups, we still trail the anesthesiologists' PAC by a 2:1 ratio in fundraising every year.
